### TERMS & CONDITIONS

- 1. Bidding Documents can be obtained free of cost, during the working hours (10:00 hours to 1600 hours) from the undersigned's office. Can also can be downloaded from websites of PPRA www.ppra.org.pk or NICL www.nicl.com.pk.
- 2. Bidding will be conducted under National Competitive Bidding pursuant to 'Single Stage Two Envelopes Procedure as per S.R.O 1077(I)/2010 of Public Procurement Rules 2010 and is open to all eligible Bidders as defined in the Public Procurement Rules 2010Rule **3B** (i) Method for Selection of Consultants. The PPRA 2010 Section **B. Quality and Cost-based selection** states that this method shall be used where high quality is the prime consideration while cost is a secondary consideration.
- 3. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion.
- 4. Initially, only the envelope marked "TECHNIACL PROPOSAL" shall be opened.
- 5. In first step, the Technical Proposals shall be evaluated. NICL may discuss its technical details, if it may deem necessary.
- 6. The envelope marked as "FINANCIAL PROPOSAL" Shall be retained in the custody of the NICL without being opened.
- 7. NICL shall evaluate the "TECHNICAL PROPOSAL" without reference to the price and may reject any proposal which does not conform to the specified requirements.
- 8. Financial Proposals of only those companies/firms shall be opened who will be Technically qualified under this process.
- 9. After the evaluation and approval of the "TECHNICAL PROPOSAL", NICL shall at a decided date and time (Date and time Shall be communicated to the bidders in writing) within the bid validity period. The "FINANCIAL PROPOSAL" of the Technically Qualified Bidders shall be opened publicly in front of company/firm or their authorized representatives, who may like to be present.
- 10. The "FINANCIAL PROPOSALS" of bidders found Technically Nonresponsive shall be returned un-opened to the respective bidders.
- 11. A combined evaluation of Technical and Financial proposals shall be made and the applicant with the most advantageous proposal will be accepted.
- 12. The proposals should not have any over-writing or cutting. Bids with any of the aforementioned defects shall not be considered.
- 13. Bidder should Provide the complete details of the technical staff/employee along with their educational qualifications and experience.
- 14. Bidders/consultant must be registered with Pakistan Engineering Council (PEC) as MEP Consultant with relevant codes (provide copy of Registration).
- 15. The Contractor/Executor/consultant must be well conversant with the Local and International Fire Codes &Byelaws, their implementation junctures, applicable regulatory implications/obligations pre-conditions & Compulsions etc.
- 16. The Contractor/Consultant must possess PEC Registration, being mandatory to undertake specified Fire Prevention, Protection and Life Safety Jobs as well as hold adequate product, brands, quality and quantity hands on field exposure etc., followed by proactive approach towards latest Global Safety Trends etc.

- 17. The firm should be registered with Income Tax, Sales Tax Departments and should appear on Active Taxpayers List (ATL) of FBR. (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 18. The bidder should not be blacklisted/debarred by any public/private organization and the bidder, in this regard, shall furnish undertaking on stamp paper of worth Rs. 100/- duly attested by the Oath Commissioner.
- 19. The successful bidder must have on-job knowledge/experience of Installation, Operations and Maintenance and up keeping of the prevention, protection and Life Safety parameters, preferably within the High-rise buildings situated inside and around Islamabad Capital Territory (ICT) and/or other big-cities/organizations within the definition of High-Rise buildings.
- 20. The successful bidder/consultant must possess a working exposure with the "Authority Having Jurisdiction (AHJ) i.e., Director of Emergency & Disaster Management (E&DM)/MCI, which includes and not limited to (i) obtaining Fire and Safety Design approvals (ii) Obtaining completion certificate of the completed projects (iii) having operations & Maintenance type activities vetted by/through AHJ and consistently engaged within territorial limits of "ICT" for specific Fire & Safety jobs not less than 10 years, (provide evidence).
- 21. The successful bidder shall provide a live demonstration of his action plan on multimedia, identifying the plan of action including time frame, quantity to quality, maintenance, up keeping and all allied modalities etc.
- 22. The bidders must possess and furnish an active/updated list of its clients, approved design, obtained completion and overall handled projects, independently or as team, which may also be visited and physically seen by team of NICL, to evaluate performance effectiveness and efficiency.
- 23. The firm must have an operational office within Islamabad, possess technical and reliable Human Resource to be verified and visited by the team of NICL for their existing stature as PEC certified firm and review the strength and weaknesses.
- 24. The NICL reserves the right to accept or reject any or all the bids on aforementioned technical grounds.
- 25. The bidder shall be required to submit a Pay Order (with Financial Proposal) for a sum equivalent to 2% of the total value (in Pak Rupees) of the bid as Bid Security (Refundable) in favor of National Insurance Company Limited, payable at Islamabad.
- 26. Bids, which are not accompanied by the documents at serial No.14, 15, 16, 17, 18, 19, 20, 22& 23 above, shall be declared non-responsive and their financial proposal will be returned unopened.

- 29. Only one authorized representative per bidder (who may want to be present) will be allowed to attend the opening of bids.
- 30. All the workers provided by the successful bidder will be obligated to maintain decorum. Non-compliance of which may result in imposition of penalty/fine on the consultant.
- 31. The entire financial liability in respect of Obtaining Fire & Safety NOC from Emergency & Disaster Management Directorate (E & DM) & Final Completion Certificate from BCS, CDA for NICL Building Islamabad shall be responsibility of the successful bidder.
- 32. The successful bidder shall be responsible for the completion of the project. All related visits of consultants or its team shall be included in the quoted financial bid, no extra payment/cost would be made.

- 33. Upon selection, the selected bidder shall not be allowed to transfer, assign, pledge, or sub-contract its rights and liabilities under this agreement to any other service provider or organization.
- 34. Payment will be made (in Pak Rupees subject to the deduction of government taxes) after satisfactory completion of work as mentioned in **ANNEX-I** and submission of Completion Certificate of each job, production of the Bill/GST invoices.
- 35. Payment will be made subject to clearance of Anti Money Laundering/Counter Financing Terrorism (AML/CFT).
