- 5. Affidavit on Rs. 100/- that the firm is not previously black-listed by any Government/ Semi-Government or Private Organizations.
- 6. The firm should have minimum of (05) five years relevant experience and should have proper office at Karachi.
- 7. Those Firms and service providers who have been black listed by any organization shall not be eligible to participate in the bidding process.
- 8. Bid Price should be on the basis of total price of bid for one year including all applicable Taxes/Levies/GST/SST.
- 9. Payment shall be made subject to deduction of government taxes, after completion of work & production of the bill/GST invoices.
- 10. The bid amount shall be inclusive of all equipment/chemicals required to be used in Rodent Control Services.
- 11. The contract shall be made for a period of one year extendable for further period with an increase of 10% yearly by mutual consent.
- 12. NICL can terminate the contract anytime by giving one month's notice on unsatisfactory performance.
- 13. The contractor will have the right to cancel the contract by giving two months notice in advance.
- 14. The successful bidder shall depute at least (02) two person to visit the building daily for 4-5 hours to monitor/cleaning/refilling of the equipment placed for rodent control and other services.
- 15. Sealed bids (alongwith dully filled in form Annex-A) are required to be delivered to the office of the undersigned as per the time schedule given in advertisement. Bids will also be opened as per the time schedule in the presence of the bidders or their authorized representatives, who may like to be present.
- 16. Bids which are not accompanied by the documents at serial No 3,4 & 5 above, shall be declared Non-Responsive and their financial proposals will be returned unopened.
- 17. The bid validity period will be 90 days starting from the last date of bid opening.
- 18. The proposal should not have any over-writing or cutting. Bids with any of the aforementioned defects may not be considered.
- 19. Workmen safety in any case is the sole liability of the contractor. NICL will not be liable for any compensation.
- 20. In view of the public health the equipment must be harmless to human body especially pregnant women and heart peace makers.
- 21. Bid application form must be filled complete & properly, otherwise it will be considered as Non-Responsive.
- 22. Incorrect information of any sort shall make the firm liable for the debarring from this contract in NICL, even after award of the contract.
- 23. Copies of National Tax (NTN) & Sindh Sales Tax certificates should be attached.
- 24. The payment of all taxes is the responsibility of the bidder/ firm.
- 25. NICL shall disqualify a firm / contractor if it finds at any time that the information submitted by the firm or contractor concerning its qualification was false and materially inaccurate.

- 26. The bid contains less Earnest Money or without earnest money will not be entertained.
- 27. Pay-Order of the Earnest money will be released to unsuccessful bidders within 30 days after the award of contract to successful bidder and commencement of contract.
- 28. Earnest money of successful bidder will be retained as performance guarantee.
