2. Full Name with location of Head Office / Branch Office of the firm along with postal address, Telephone fax, email, details of organizational/administrative setup and local office in Karachi may be provided with the bidding documents.
3. Tender documents having the terms/conditions & Technical Evaluation Criteria along with the detailed scope of work, drawings & BOQ for the task can be obtained free of cost through written request from the office of the undersigned. 4. Tender will be conducted under National Competitive Bidding pursuant to ***'Single stage two envelopes procedure'*** as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible participants of tender as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria.
5. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHNIACL PROPOSAL" shall be opened.
6. The envelope marked as "FINANCIAL PROPOSAL" Shall be retained in the custody of the NICL without being opened.
7. NICL shall evaluate the "TECHNICAL PROPOSAL" without reference to the price and reject any proposal which does not conform to the specified requirements.
8. Financial Proposals of only those companies/firms shall be opened who will be technically qualified under this process.
9. After the evaluation and approval of the "TECHNICAL PROPOSAL" NICL shall at a decided time (time Shall be informed the bidders in writing) within the bid validity period open the "FINANCIAL PROPOSAL" publicly in front of company/firm or their authorized representatives, who may like to be present, of the technically qualified bidders.
10. The "FINANCIAL PROPOSAL" of bidders found technically nonresponsive shall be returned unopened to the respective bidders.
11. The Eligible Bidders (Tax Compliance) Regulations, 2015, the firm should be registered with Income Tax; Sales Tax Departments & should appear on Active Taxpayers List (ATL) of FBR&

SBR. (Registration Numbers should be clearly mentioned, and valid documentary evidence be attached).

12. The participants of the tender shall not be blacklisted/debarred by any public/private organization and the bidder, in this regard, shall furnish undertaking on stamp paper of worth Rs.100/-.
13. The participants of the tender shall be required to submit a Pay Order/Bank Draft for a sum equivalent to 2% of the bid amount as Security in favor of National Insurance Company Limited to be attached with the proposal. Bidding documents without earnest money would be rejected.
14. Earnest money of successful bidder will be retained as performance guarantee.

20. Bids which are incomplete, not sealed, or late or submitted by other than specified manner shall be returned un-opened.
21. The proposals should not have any over-writing or cutting. Bids with any of the aforementioned defects will not be considered.
22. Each paper of Tender Document should be signed & stamped by an authorized person of the firm.
23. The bids received by fax or e-mail shall not be accepted.
24. Only one authorized representative per participant of the tender will be allowed to attend the bid opening session.
25. The entire financial liability in respect of Renovation work (both wings) 2nd & 3rd floor toilet at NICL, Head Office, NICL building, Abbassi Shaheed Road, Karachi as mentioned in the scope of work would be the sole responsibility of the selected company/firm.
26. Upon selection, the selected company/firm shall not be allowed to transfer, assign, pledge, or sub-contract its rights and liabilities under this agreement to any other service provider or organization.
27. The pre-qualified firm/company must be financially sound to be willing to do business on a credit basis. The payment would be made after the satisfactory completion of work.
28. Payment will be made subject to the deduction of government taxes, after completion of work & production of the Bill/GST invoices.
29. The site can be visited on any working day i.e., Monday to Friday between **09:00 AM to 5:00 PM**.

30. NICL may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. NICL shall upon request communicate to any supplier or contractor who submitted a bid or proposal the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
31. NICL shall disqualify a firm if it finds at any time that the information submitted by the firm concerning its qualification was false and materially inaccurate.
32. The participants of the tender shall bear all costs associated with the preparation and submission of their respective Proposals and NICL will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification/enlistment process.
33. A company/firm will be selected after an open and transparent tendering process in accordance with Public Procurement Regulatory Authority (PPRA) Ordinance, 2002, and Rules, Regulations and Guidelines.
34. NICL may reject any or all proposals at any time prior to its acceptance.
