- 2. Full Name with location of Head Office / Branch Office of the firm along with postal address, Telephone fax, email, details of organizational/administrative setup and local office in Karachi may be provided with the bidding documents.
- 3. Bidding Documents can be downloaded from websites of PPRA www.npra.org.pk & NICL www.nicl.com.pk or can be obtained free of cost from the office of the undersigned.
- 4. Bidding will be conducted under National Competitive Bidding pursuant to 'Single stage two envelopes procedure, a bid shall comprise of single package containing two separate envelopes, as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:
 - a. Bidders must be authorized by their OEM(s) specifically for this procurement.
 - b. The offered product(s) must have been installed at minimum 3 verifiable organizations in Pakistan during last 3 years
 - c. Bidder must provide relevant work orders with the bidding documents.

- 5. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHNIACL PROPOSAL" shall be opened.
- 6. The envelope marked as "FINANCIAL PROPOSAL" Shall be retained in the custody of the NICL without being opened.
- 7. NICL shall evaluate the "TECHNICAL PROPOSAL" without reference to the price and reject any proposal which does not conform to the specified requirements.
- 8. Financial Proposals of only those companies/firms shall be opened who will be technically qualified under this process.
- 9. After the evaluation and approval of the "TECHNICAL PROPOSAL" NICL shall at a decided time (time Shall be informed the bidders in writing) within the bid validity period open the "FINANCIAL PROPOSAL" publicly in front of company/firm or their authorized representatives, who may like to be present, of the technically qualified bidders.
- 10. The "FINANCIAL PROPOSAL" of bidders found technically nonresponsive shall be returned unopened to the respective bidders.

- 11. The Eligible Bidders (Tax Compliance) Regulations, 2015, the firm should be registered with Income Tax; Sales Tax Departments & should appear on Active Taxpayers List (ATL) of FBR& SBR. (Registration Numbers should be clearly mentioned, and valid documentary evidence be attached).
- 12. The firm should be registered with Income Tax; Sales Tax Departments& should appear on Active Taxpayers List (ATL) of FBR. (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 13. The Eligible Bidders should have valid PEC Registration.
- 14. The bidder should not be blacklisted / debarred by any public/private organization and the bidder, in this regard, shall furnish undertaking on stamp paper of worth **Rs. 100/-.**
- 15. The bidder shall be required to submit a Pay Order for a sum equivalent to 2% of the total value of the bid as Bid Security in favor of National Insurance Company Limited, payable at Islamabad.
- 16. Earnest money of successful bidder will be retained as performance guarantee.
- 17. Bid Security/Earnest Money shall be returned/released to the unsuccessful participants of the tender(s) once this process has been completed/finalized.
- 18. Bid price should be on the basis of total price of bid including all applicable Taxes/ Levies/GST/SST.
- 19. Bids, which are not accompanied by the documents at serial no. 2, 9, 11, 12 & 13 above, shall be declared non-responsive and their financial proposal will be returned unopened.
- 20. Sealed Bids are required to be delivered at office of the undersigned on or before **Date 31-5-2023** time 11.00 A.M.
- 21. The Bid Opening Committee of NICL will open the quotation / bids, on the same day **Date 31-5-2023 time 11.30 A.M** in the presence of the bidders or their authorized representatives, who may like to be present.
- 22. The job is Supply, Installation, Testing and Commissioning of Flap Barrier with complete timeline schedule (to be given by the bidder).
- 23. In case of any injury, fatal or otherwise, to the workers occurred during work, it will not be the liability of NICL.
- 24. All the workers provided by the contractor will be obligated to maintain decorum and non-compliance to which may result in imposition of penalty / fine on the contractor.
- 25. The entire financial liability in respect of machinery, workers deployed and other items shall be borne by the contractor and the office concerned will in no way be liable.
- 26. The contractor shall be solely responsible for redress of grievances or resolution of disputes relating to the deployed workers. NICL shall, in no way, be responsible for settlement of such issues whatsoever.

- 27. Accommodation and meals / refreshments for the workers would be the responsibility of the contractor.
- 28. The contractor shall ensure that adequate supervision of his workers be provided on site at all time during the progress of the works.
- 29. The contractor shall confine his workmen strictly within the areas of work involved and work must be carried out with the minimum of noise and no nuisance in any form should be created.
- 30. Upon selection, the selected bidder shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this agreement to any other service provider or organization.
- 31. Only one authorized representative per bidder will be allowed to attend the opening of bids.
- 32. Payment will be made only after satisfactory completion of work and submission of completion certificate.
- 33. Payment will be made subject to the deduction of government taxes, after completion of work & production of the Bill/GST invoices.
- 34. The proposals should not have any over-writing or cutting. Bids with any of the aforementioned defects will not be considered.
- 35. The site can be visited on any working day between 09:00 AM to 12:30 PM.
- 36. NICL may reject all bids or proposals at any time prior to the acceptance of a bid or proposals. NICL shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- 37. No bidder shall be allowed to alter or modify his bid after the bids have been opened. However, the NICL, being the procuring agency, may seek and accept clarifications to the bid in written that do not change the substance of the proposal.
- 38. Bids which are incomplete, not sealed, or late or submitted by other than specified manner shall be returned un-opened.
- 39. The proposals should not have any over-writing or cutting. Bids with any of the aforementioned defects will not be considered.
- 40. Each paper of Tender Document should be signed stamped by an authorized person of the firm.
- 41. The bids received by fax or e-mail shall not be accepted.
- 42. The entire financial liability in respect of Supply, Installation, Testing and Commissioning of Flap Barrier with associated equipment & services at NICL Building Karachi as mentioned in the scope of work would be the sole responsibility of the selected company/firm.

- 43. Upon selection, the selected company/firm shall not be allowed to transfer, assign, pledge, or sub-contract its rights and liabilities under this agreement to any other service provider or organization.
- 44. The pre-qualified firm/company must be financially sound to be willing to do business on a credit basis. The payment would be made after the satisfactory completion of work.
- 45. NICL may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. NICL shall upon request communicate to any supplier or contractor who submitted a bid or proposal the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
- 46. NICL shall disqualify a firm if it finds at any time that the information submitted by the firm concerning its qualification was false and materially inaccurate.
- 47. The participants of the tender shall bear all costs associated with the preparation and submission of their respective Proposals and NICL will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification/enlistment process.
- 48. A company/firm will be selected after an open and transparent tendering process in accordance with Public Procurement Regulatory Authority (PPRA) Ordinance, 2002, and Rules, Regulations and Guidelines.
- 49. NICL may reject any or all proposals at any time prior to its acceptance.
- 50. NICL requires that participants of the tender under their contracts observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy following terms are defined as hereunder:
 - a. "Corrupt practice" includes offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party.
 - b. "Fraudulent practice" includes any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation.
 - c. "Coercive practice" includes impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party.
- 51. In case the first lowest pre-qualified bidder fails to provide the required services or NICL is not satisfied with the provided services, NICL reserves the right to obtain the services from second lowest bidder. In case the second lowest pre-qualified bidder fails to provide the required services or NICL is not satisfied with the provided services, the NICL reserves the right to obtain the services from third lowest bidder.
- 52. All offers should be valid for 90 (Ninety) calendar days from the date of opening of Tender.
- 53. All material/ parts required to complete the above task in a satisfactory manner will be arranged by the Successful Firm/Company/Contractor. However, the cost of the same may be included in the financial proposal.
- 54. The Bidder may withdraw its Technical Proposal and Financial Proposal after it has been submitted by sending a written Withdrawal Notice, duly signed by the Bidder and/or by an authorized representative,

- and shall include a copy of the authorization. Provided that, written notice of Withdrawal, shall be received by NICL prior to the opening of bids.
- 55. No bid shall be withdrawn in the interval between the opening of Bids and the expiration of the period of Bid validity specified in ITB section.
- 56. The pre-qualified firm/company must be financially sound to be willing to do business on a credit basis. The payment would be made after the satisfactory completion of work.
