- The bid (s) should be accompanied with copy of CNIC & Pay Order equivalent to 10% of bid price for Salvage/Junk /Misc. Items as 'Earnest Money' in favor of National Insurance Company Limited, Karachi which will be returned to unsuccessful bidders after completion of the biding process.
- 3. Tender will be conducted under National Competitive Bidding pursuant to 'Single stage one envelopes procedure' as per Rule 36(a) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible participants of tender as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria.
- 4. Security shall be returned/released to the unsuccessful participants of the tender(s) once this process has been completed/finalized.
- 5. In case any bidder forfeits his bid, the bid security/money would not be returned and would be held/enchased as penalty by NICL.
- Sealed proposals are required to be delivered at office of the undersigned on or before Date 31-5- 2023, time 3:00 P.M.
- 7. The Bid Opening Committee of NICL shall open the proposals, on **Date 31-5-2023** at **3:30 P.M** in the presence of the authorized representatives, who may like to be present.
- 8. Only one authorized representative per participants of the tender will be allowed to attend the opening of bids.
- 9. The proposals should not have any over-writing or cutting. Bids with any of the aforementioned defects will not be considered.
- 10. NICL may reject all bids or proposals at any time prior to the acceptance of a bid or proposals.
- 11. NICL shall upon request communicate to any bidder who submitted a bid or proposal, the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
- 12. The participants of the tender shall bear all costs associated with the preparation and submission of their respective Proposals and NICL will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification/enlistment process.
