- 2. All material/parts required to undertake the required work will be arranged by the Contractor and the cost of the same should be included in the financial proposal.
- 3. Only those firms / Companies having valid NTN & GST / PEC Registration and on Active Taxpayers list of FBR (attach valid documentary evidence) are eligible to participate in the Bidding process.
- 4. Bids should be accompanied by 2% (Two Percent) as Bid Security of the respected quoted amount in shape of Pay Order / Bank Draft in favor of National Insurance Company Limited, Islamabad.
- 5. Affidavit on Rs.100/- Stamp Paper that the firm is not black listed by Government / Semi Government or Private Organization.
- 6. The firm should have minimum of (05) five years relevant experience and should have proper office.
- 7. Those Firms who have been blacklisted by any Organization shall not be eligible to participate in the bidding process.
- 8. Bid price should be included with all applicable Taxes/ Levies/GST.
- 9. Payment shall be made subject to deduction of Government Taxes, after completion of work & production of the GST invoice.
- 10. - 11. Bids which are not accompanied by the documents at serial No. 4,5 & 6 above shall be declared non-Responsive and declared as disqualified. The bid validity period should be 90 days starting from the date of bid opening.
- 12. The proposal should not have any overwriting or cutting. Bids with any of the aforementioned defects shall be rejected.
- 13. Workmen safety in any case is the sole liability of the firm / Contractor. NICL will not be liable for any compensation.
- 14. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
- 15. Bid application form must be filled complete & properly, otherwise it will be considered as Non-Responsive, and will be rejected.
- 16. Incorrect information of any sort shall make the firm liable for the debarring from this contract in NICL, even after award of the Work Order.

- 17. Copies of National Tax number (NTN certificate) General Sales Tax (GST certificate) & Valid PEC must be attached.
- 18. NICL shall disqualify a firm / contractor if it finds at any time that the information submitted by the firm concerning its qualification was false and materially inaccurate.
- 19. If the bid contains less Bid Security or without Bid Security that will not be entertained.
- 20. Pay-Order of the Bid Security will be released to unsuccessful bidders within 30 days after the award of contract to successful bidder and commencement of contract.
- 21. Bid Security of successful bidder will be retained as performance guarantee.
- 22. Bids received by Fax or email shall not be accepted.
- 23. Conditional, Multi Optional bids will not be accepted.
- 24. Successful firm shall be bound to complete the task up to the satisfaction and the acceptance by the NICL.
- 25. Brief Company Profile, Book-Lets and Brochures should be enclosed/attached with the Bidding documents.
- 26. Sealed Bids forms duly completed should reach on or before the specified deadline.
