3. Eligibility Criteria

- a. Participants of the tender failing in mandatory requirements (Section – A) will be disqualified.

Mandatory Requirements (Section – A)

1.	The workshop must be in at least one of the cities mentioned under Locations and must be mentioned in Annexure B – Workshop Details Form (as applicable) Attach ownership documents/tenancy agreement with last paid electricity bill and Annexure B with application submitted.		
2.	The workshop must have experience of at least 3 years on the date of deadline of submission of application. Attach NTN certificate/registration certificate/any other document with clear date.		
3.	The workshop must have completed at least 3 repair and maintenance services for clients (other than NICL) in Pakistan in the past 3 years. Attach letter /work order/purchase order issued.		
4.	The workshop must not be on Active Blacklisted Firms list on PPRA website during evaluation of applications by the evaluation committee.		
5.	The workshop must be an Active Taxpayer with Federal or Provincial Tax Authority (as applicable as per location) at the time of evaluation of applications by the evaluation committee. Attach NTN certificate for verification		
6.	The workshop must accept all requirements of NICL. Attach signed and stamped copy of these bidding documents

5. Prequalification Process

- The process shall be conducted following the Single Stage – Single envelope procedure with Least Cost Basis as per PPRA Rules.
- Opening shall be done as per schedule above in presence of vendors (as present) at Conference Room, 3rd Floor, NICL Building, Abbasi Shaheed Road, Karachi.
- Evaluation shall be conducted for all applications as per requirements stated under Eligibility Requirements and all those who qualify shall be qualified and accepted for a contract period of 3 years through open framework agreements with assignments on need basis as per requirements of NICL.

6. Application Submission Requirements

- The application, with all documents attached, shall be submitted in a single sealed envelope with title of the task and name of firm and shall be dispatched/dropped in the tender box outside the room of Manager Procurement at address mentioned below by the deadline of **7th September 2026 at 10:30 am**.

- a. 8. Application Validity

- a. All applications and related information submitted must be valid for a period of **90 days** from the date of opening of the applications to allow NICL to evaluate and seek approval for appointments of all qualifying firms.

9. Delivery Time

- a. The successful bidder must ensure delivery/completion within days mentioned in work order.
- b. Delivery of the vehicles be at the NICL office/branch where workshop is located.
- c. The vendor shall ensure timely completion of services to minimize disruption to NICL office operations.

10. Payments Schedule

- a. Payment will only be made after a successful 07 x days road test and full inspection of the vehicle verifying the quality of repairs for each car individually or together based on completion and issuance of invoice accordingly.
- b. The payment shall be made within 30 days after satisfaction of Point above.
- c. Payment shall be issued after deduction and withholding of taxes as per rules and documents submitted for any tax exemptions.

11. Penalty

- a. In case of delay in delivery of a maximum of 2 weeks beyond the stated delivery time in work order, a penalty of 0.1% per day of the total amount (inclusive of GST/other charges) shall be applicable and deducted from the payment issued by NICL. This shall also be mentioned in the work order issued by NICL.
- b. In case of delay in delivery of more than 2 weeks, the work order shall be cancelled and shall be awarded to the 2nd lowest participant and next lowest in series thereafter.

- c. In case of cancellation of work order due to failure to supply goods or services within the maximum period stated by NICL, the bidder shall also be placed on Active Blacklisted Firms on PPRA website as per PPRA rules.
- d. Penalty shall not be applicable in conditions of any force majeure.

12. Instructions/General Conditions

- a. Joint Venture (JV) shall not be allowed, and single supplier is allowed to submit application with documents related to the firm/company only.
- b. The applicants will be selected after an open, competitive, and transparent bidding process in view of Rule 20 of PPRA Rules, 2004.
- c. Application/Bids submission must be in English language only.
- d. Each page of the EOI documents shall be signed by authorized representative of the bidder.
- e. In case of any clarifications required by suppliers regarding the EOI documents, they may submit them for Clarification via email procurement@nicl.com.pk by 1st September 2026 at 05:00 PM.
- f. NICL may reject all applications/bids at any time prior to the award of contract. NICL shall communicate to all bidders who submitted applications/bids, the grounds for its rejection of all bids or proposals but is not required to justify those grounds as per Rule 33 of the PPRA Rules, 2004.
- g. The pre-qualified applicants shall be appointed through open framework agreements to provide the services to NICL on an as and when required basis.
- h. The applications which are not accompanied by the documents required as per the bidding documents shall be declared non-responsive and the applications will be rejected.
- i. Incomplete or late submissions shall not be accepted, and any false information shall lead to disqualification and consideration for blacklisting as per PPRA Rules.
- j. Enlistment does not guarantee award of work; jobs will be assigned as per NICL's requirements.
